4. **Affiliate Legal Personnel:** A person who is employed by a current member of the State Bar of California as staff (includes paralegals, administrative law clerks, assistants).

5. **Student:** A person regularly enrolled in a law school in the State of California as a candidate for a law degree, or a graduate of any law school who has not yet passed the California Bar Examination.

6. **Retired/Inactive:** Eligible to those who are inactive from the State Bar of California.
